

2023 ULTRA UNICORN RAFFLE TERMS AND CONDITIONS

Raffle Ticket: For the purposes of this raffle, a raffle ticket will be defined as a digital entry in the raffle. Participants will be entered into the raffle by providing their name and other relevant information and will not receive physical tickets. The list of eligible participants will be maintained on a Word document and periodically posted on our website. Eligibility:

- You must be 18 years of age or older to enter.
- You must be located within 2 hours of Lawton, Oklahoma.
- To be eligible to win, you must be present at the drawing.

Entry Period:

- You may enter to win between January 1st, 2023 and April 9th, 2023.

How to Enter:

- There are multiple ways to enter the raffle:
- Fill out our questionnaire to earn a chance to win a raffle ticket.
- Purchase raffle tickets directly through us.
- Rent an inflatable during the eligibility period to receive an additional ticket for each event.
- Participate in our weekly live drawings held on Facebook. 3 names will be drawn each week and each person will receive a raffle ticket.
- If you have signed up for our marketing list, you will be eligible to participate in the weekly drawings.
- If the number of entries does not reach 1,000, we may add additional tickets to satisfy demand by randomly selecting names from our marketing list, however, we will first offer the opportunity to purchase additional tickets.

Number of Entries:

- 20 entries max per person.

Drawing:

- There will be a total of 1,000 tickets in the drawing. We reserve the right to add more tickets if necessary to satisfy demand.
- The weekly drawings will be held live on Facebook, where 3 participants will be randomly selected to win a raffle ticket.
- In the event that the number of participants on the day of the event does not reach the cap of 1,000, eligible participants from our marketing list may be added to the pool until it reaches the cap of 1,000. Prior to adding their names to the pool, participants will be offered the opportunity to purchase tickets.

- The final drawing will be held live on Facebook starting on April 10th, and the wheel will be spun once to determine the winner.

Prize:

- The prize is our Ultra Unicorn Bounce House & Water Slide Combo.
- Upon winning, we will deliver it to you, set it up, clean it if necessary, and go over safety procedures. We will then power it down and show you how to store it. This inflatable does not come with a blower or any other accessories, other than stakes. Delivery must be within 2 hours of Lawton, OK, or extra fees will apply.
- The prize cannot be transferred or redeemed for cash.

Claiming the Prize:

- Upon winning, please reach out to us on the live stream in chat to verify you are present.
- You will have 1 minute to claim the prize.
- If the prize is not claimed within 1 minute, it will be forfeited and we will spin the wheel until the prize is claimed..
